We need your help Here and Now, as at present we only have EUR 70.000 / INR 4,830,000 and will need another EUR 180.000 / INR 12,420,000.

Unfortunately there is a delay in construction. On the one hand financial support is not yet sufficiently provided for, on the other hand Indian beaurocracy is working slowly, thus for months we have been waiting for the last document permitting the construction. As the saying goes:
„Rome wasn't built in one day!“

Furthermore it is so, that prices are constantly rising: The longer we are waiting, the more expensive the building will be! The construction costs for the first three houses are of EUR 150.000 / INR 10,350,00, using a simple, but eco-friendly construction method.

In order to cover the costs for the living of the children, of the foster mother and the administration, we will need another starting fund of Euro 100.000. Thus we can cover the monthly living with the bank interest.
